1.0 Introduction:

ENARMAC Nigeria Limited is a specialized Consultancy outfit whose main focus is on Natural Resources Conservation and Environmental Management for Sustainable Development. The Consultancy outfit is fully registered with the Corporate Affairs Commission (CAC) and has its temporary office at Room 2-037, 2nd Floor, Engr. 2.0 Aim and Objectives:

- **2.1 Aim:** To make meaningful contribution to human development and environmental protection through the promotion of best practices for sustainable environmental management. The scope of activities covers all aspects of environmental management and natural resources conservation.
- **2.2 Objectives:** The broad objective is to engage in all activities that can promote natural resources conservation, sustainable environmental management and socio-economic development. The specific objectives include:
 - (i) To provide consultancy services on environmental management and natural resources conservation;
 - (ii) To engage in development and review of policy instruments for the enhancement of sustainable environmental management and natural resources conservation;
 - (iii) To engage in the production and review of Environmental Impact Assessment Reports;

5.0 Associated Experts:

6.0 Work Experience:

- Although the Company has just been incorporated in March 2017, the Managing Director/Chief Executive Officer has been involved in many environmental issues for over thirty years. As a retired Federal Director of Forestry, he has a wide range of experience in environmental management and sustainable development issues, both at national and international levels. He is supported by a team of experts in various subject areas, such as natural resources assessment and management, forest and biodiversity conservation, landscape horticulture, forest ecology, health and environment, human habitat, industrial and technology education, and sustainable livelihoods.
- 6.2 One of the priorities of the Company is to facilitate the domestication of international conventions and agreements on environmental matters through community engagement in natural resources conservation and environmental management activities for livelihood support and sustainable development. Currently, the Company is working with a Community-based Organization (The Great League of Pioneers, Otun Ekiti), to ensure the continuous protection of the 10ha Community Herbal Heritage Centre in Otun Ekiti, which was established since July 1993, following the adoption of the Convention on Biological Diversity during the United Nations Conference on Environment and Development (UNCED)

held in Rio de Janeiro, Brazil, in June 1992. The 10ha project site which used to be a fallow farm land has now grown into climax vegetation.

- 6.3 In May 2017, the Chief Executive of ENARMAC led the team of experts from Federal Ministry of Environment to undertake some project activities which included:
 - (a) Interactive session with Conservation Club at the Community School (Moba Grammar School, Otun Ekiti);
 - (b) Interactive discussion with Community leaders on the project objective and expected role of the Community;
 - (c) Botanical rambling with Community members to identify medicinal plants that are in the Herbal Heritage Centre;
 - (d) Natural resources assessment to facilitate the development of management plan for the project; and
 - (e) Perimeter fencing of the project site with barbwire.
- 6.4 Certainly, the perimeter fencing of the project site will help protect the conservation area from encroachment as town development has reached its surroundings.

- 6.5 Since the primary objective was for the conservation of all indigenous plant species endowed the Community, ENARMAC Nigeria Limited would like to facilitate:
 - (a) Ethnobotanical survey of the project site to determine the conservation status of existing species as well as their utilization potential for inhabitants of the Community;
 - (b) Development of nature trails in the project site, with a view to promoting the use of the place for ecotourism in the near future;
 - (c) Grading of the access road to the project site and construction of rides around the project site to facilitate easy access; and
 - (d) Establishment of a plant nursery in the Community Herbal Heritage Centre for the purpose of raising seedlings of endangered species of medicinal and horticultural plants;
 - (e) Development of water resources in the project area for livelihood support for the community;

(f) Reactivation of Young Foresters Clubs in the Community High School (Moba Grammar School, Otun Ekiti) and possible expansion to other Primary and Secondary Schools within the community.

6.6 In line with the above objectives, ENARMAC Nigeria Limited has, in 2018, undertaken feasibility studies for three priority projects for the sustainable management of the Community Herbal Heritage Centre, namely:

(i) Establishment of a bottle water production facility;

(ii) Fish production; and

(iii) Establishment of a standard medium scale Plant Nursery for raising seedlings of ornamental, horticultural and endangered medicinal plant species, as well as providing technical training opportunities for self-employment for young school leavers.

6.7 The feasibility studies also covered other associated infrastructures such as the project office, access roads/rides and nature trails. The estimated cost of the projects was about N288million (an equivalent of \$800,000).

6.8 The projects are expected to provide direct and indirect employment opportunities for about one hundred people in the first instance. In anticipation of sponsorships for these projects, ENARMAC has also developed a comprehensive project implementation strategy to ensure sustainability and maximize the benefits to the Community. ENARMAC would be glad to meet with any Organization, Associations or individuals willing to help sponsor any of the identified projects, even if it has to be a kind of soft loan that could be refunded within a period of three to five years.

6.9 It is our hope that the project site can become a valuable research centre for community sustainable development in future.
